Disabled Veteran Permit.....

*Coos County Parks will accept a valid Oregon State Park pass for Veterans with Disabilities. *Must show valid pass and ID upon check-in.

*Without a valid pass customer will be charged full price.

*Good for five free nights in a RV or tent space ONLY and a max of 10 nights in a month.

*Good for free day use parking at any County Park that has a day use fee.

*The \$12.00 reservation fee still applies.

*The person eligible for the pass must occupy the site.

 credit is to be received in full.

 One week50%

Camp Fees Refund Policy - No cash refunds allowed at parks. The
 reservation fee is non-refundable, no exceptions. Prior to 72 hours (3
 days) notice, Coos County Parks will refund your camping fee. Less than
 72 hours notice, Coos County Parks retains your first night camping fee
 and the reservation fee.

Large Group Camping Refund Policy

Cancellations are required at least 60 days in advance (in writing) if
 credit is to be received in full.

Cancellation prior to event refund due:

Prior 60 days100%
 Prior 45 days75%
 Prior 30 days50%
 Prior 15 days25%
 Less than 15 days0%
