1 BOARD OF COMMISSIONERS 2 COUNTY OF COOS 3 STATE OF OREGON 4 In the Matter of Declaring a County State of Emergency 5 ORDER 12-03-022L 6 7 WHEREAS, ORS 401.305 provides authority for Coos County to act as an emergency 8 management agency, including authority to establish policies and protocols for defining and directing responsibilities during time of emergency; and 9 WHEREAS, Coos County has enacted a local ordinance (County Code Article 10) 10 pursuant to the authority granted by ORS Chapter 401, that provides for executive responsibility 11 in times of emergency and specifically delegates authority to declare a state of emergency to the Chair of the Board of Commissioners; and 12 WHEREAS, the following conditions have resulted in the need for a state of emergency: 13 Severe weather, consisting of snow, heavy rains, and high winds has caused a significant number 14 of fallen trees and other hazardous debris on County roads including a high risk of landslide; 15 WHEREAS, the following damage to life and property can be expected from the above 16 conditions: 17 Damage to vehicles and risk of serious physical injury to persons driving on County Roads by the falling of trees not immediately cut down or removed from right of ways or roads; 18 WHEREAS, the entire County is in a state of emergency. 19 20 NOW, THEREFORE, IT IS HEREBY ORDERED that: 21 1. The Chair formally declares a state of emergency for Coos County, effective on 15the day of March, 2012 at 8:30am for the entire County. 22 2. The Coos County Office of Emergency Management in conjunction with the Coos County 23 Sherriff's Office shall hereby take all necessary measures including but not limited to: 24 a) prohibit or limit the number of persons who may gather or congregate upon any public 25 street or place or any outdoor place within the area designated as an emergency area; b) barricade all streets, roads, and access points to the same, and prohibit vehicular or 26 pedestrian traffic, or restrict or regulate the same in any reasonable manner in the area

designated as an emergency management area for such distance or degree of regulation as

The Zonta Club of Coos Bay Area granted \$2,000 to support women's health services; the Coquille Tribal Community Fund granted \$5,000 to support clinic services to both women and men; and CCFoPH held a Purses for Nurses fundraiser, with net proceeds of \$6,897.99, to support women's health services. These funds are now available to Coos County Public Health.

These funds help Coos County Public Health provide services that are not covered by other federal programs, to women and men, to ensure the most comprehensive care possible.
