**Adopting Updates to the Coos County
Multi-Jurisdictional Natural Hazards Mitigation Plan**

Whereas, Coos County recognizes the threat that natural hazards pose to people, property and infrastructure within our community; and

Whereas, undertaking hazard mitigation actions will reduce the potential for harm to people, property and infrastructure from future hazard occurrences; and

Whereas, an adopted Natural Hazards Mitigation Plan (NHMP) is required as a condition of future funding for mitigation projects under multiple FEMA pre- and post-disaster mitigation grant programs; and

Whereas, Coos County fully participated in the FEMA prescribed mitigation planning process to prepare this Natural Hazards Mitigation Plan; and

Whereas, the Oregon Office of Emergency Management and Federal Emergency Management Agency, Region X officials have reviewed the *Coos County Multi-Jurisdictional Natural Hazard Mitigation Plan* and pre-approved it (dated, May 31, 2016) contingent upon this official adoption of the participating governments and entities;

Whereas, the NHMP is comprised of two volumes: Volume I -Basic Plan and Volume II - Appendixes, collectively referred to herein as the NHMP; and


Whereas, the NHMP is in an on-going cycle of development and revision to improve it's effectiveness; and

Whereas, Coos County adopts the NHMP and directs the Emergency Management Program Manager to develop, approve, and implement the mitigation strategies and any administrative changes to the NHMP.

Now, therefore, be it resolved, that Coos County adopts *the Coos County Multi-Jurisdictional Natural Hazards Mitigation Plan* as an official plan; and

Be it further resolved, that Coos County will submit this Adoption Resolution to the Oregon Office of Emergency Management and Federal Emergency Management Agency, Region X officials to enable final approval of the *Coos County Multi-Jurisdictional Natural Hazards Mitigation Plan*.
