Crime(s): Conspiracy to MCS, PCS DCS Methamphetamine, MCS, PCS, DCS Marijuana, Theft I by receiving, two counts of theft II by receiving, located wanted subject and frequenting a place where a controlled substance is used

Narrative:

On September 23rd, 2011 at approximately 4:00 p.m., the South Coast Interagency Narcotics Team (SCINT), with the assistance of the Coos Bay Police Department and Brookings Police Department; executed a narcotics search warrant at 777 West Hemlock, Apt #4, Coos Bay. The occupant of the residence, Timothy Groves 51 YOA and six additional persons were contacted, five of which were arrested. (charges listed below) all were contacted at the time of the warrants execution. A 17 year old male juvenile was released to his mother with charges referred to the Coos County juvenile department.

During the search of the residence Officers located and seized in excess of 150 grams of crystal methamphetamine with an associated street value over \$10,000.00, methamphetamine use paraphernalia, scales, packaging material, marijuana in excess of 40 grams, over \$1,200.00 in US currency, gold bullion and stolen property from three thefts.

Mr. Groves was taken into custody for Possession, Delivery, and Manufacture of Methamphetamine, Marijuana, Theft 1 by receiving and two counts of theft II by receiving.

A subject located at the residence initially false identified himself to Detectives; He was later identified as Richard Sakschewski and had multiple warrants from two counties for his arrest for false information.

One of the stolen items recovered was a high school class ring taken in Waco, Texas in 2009. Detectives used Face Book to find the owner.

Additional subjects arrested and charges:

- 1. Kenneth Jankowski 44 YOA of North Bend, Frequenting a Place where controlled substances are used.
- 2. Christopher Postlethwait 18 YOA of Coos Bay, Frequenting a Place where controlled substances are used.
- 3. Wanda Marble, 50 YOA of North Bend, PCS methamphetamine and Frequenting a Place where controlled substances are used.
- 4. Timisha Groves 18 YOA, Frequenting a Place where controlled substances are used.
- 5. Richard Sakschewski 31 YOA of North Bend, two warrants, false information and Frequenting a Place where controlled substances are used.

All subjects arrested were transported to the Coos County Jail and booked. Due to the amount of methamphetamine recovered the case will be referred to the Assistant United States Attorney in Eugene, Oregon for adoption by the DEA on Federal charges.
