Ordinance 93-02-002L (93-1-1195) - Revised Article Seven, Division One, 07.01.220, to extend the term of franchises from five (5) to ten (10) years with automatic renewal.

Ordinance 93-03-007L (93-1-1646) - Added Division Two to Article Seven to add a Protected Resource Activity provision intended to address protecting, preserving and providing for the continuance of resource activities in the County.

Ordinance 93-03-008L (93-1-1652) - Added Division Two to Article Eleven to provide an accelerated redemption period for foreclosed property in the event that the property is subject to waste or, in the case of unoccupied property, a substantial depreciation in value.

Ordinance 93-08-015L (93-3-0531) - Revised Article Four, Division Eight to provide a system to assign road names and rural addresses.

 $\underline{\text{Ordinance 95-11-009L}}$  (95-3-1318) - Repealed Article Nine, Division Three as fees for services provided by the County Surveyor are no longer required to be established by ordinance.

 $\underline{\text{Ordinance }96\text{-}04\text{-}004\text{L}}$  (96-2-1161) - Extensively revised Article Two, Division Three, which is the Ambulance Service Areas and Plan.

Ordinance 97-03-001L (97-1-0939) - Added Division Eight to Article Two to add a provision implementing the duties of alarm users and the application process for alarm system permits.

Ordinance 97-04-002L (97-1-1570) - Added Division Nine to Article Two to add a provision for declaring specified crime property to be a nuisance and establishing penalties.

Ordinance 97-05-005L (97-1-1748) - Added Division Three to Article Seven to form an intergovernmental entity called Jefferson Behavioral Health.

Ordinance 97-05-007L (97-1-2208) - Added a provision to Article Two, Division Seven required by law to allow the Coos County Jail to implement the inmate property inventory policy.

Ordinance 97-08-008L (97-2-0304) - Authorizing the Economic Improvement Board to approve leases for the Business Enterprise Center; commencing the County's "No Spray" program for rights of way on February 15th instead of March 15th; authorizing special events at County Parks with a percentage of gross revenue to be paid to the County; revising the maximum time limit for camping in County Parks to 14 days and authorizing monthly camping permits during the off season; exempting fees charged by the County but established by other governmental or private bodies from the County's procedures for adopting fees; adding provisions to accept delegation of public health responsibilities from the State Health Department; and minor typographical corrections.
