COOS BAY ESTUARY MANAGEMENT PLAN (CBEMP) REVISIONS (PART 1, PART 2) AND IMPLEMENTING ORDINANCE REVISIONS

PURPOSE

This memo outlines recommendations to update Part 1 and Part 2 of the Coos Bay Estuary Management Plan (CBEMP) and related jurisdictional implementing ordinances.

The goals of this amendment package are to: 1) update Part 1, Plan Policies, as necessary to meet current state laws and regulations and make it more user-friendly; 2) update Part 2, Inventories and Factual Base, with the Coos Estuary and Shoreland Atlas (Map Atlas) and Community Lands and Waterways Data Source (data source) and adopt digitized versions of the regulatory maps associated with the CBEMP in Part 1 Appendix A; and 3) bring the three jurisdictions (Coos County, City of Coos Bay, and City of North Bend) back into alignment under one guiding document and provide tools for future plan maintenance.

This amendment package is proposed as PHASE 1. The recommended PHASE 2 is a complete update of the CBEMP. This update would involve a robust public process similar in nature to the original CBEMP drafting/adoption process in 1985 and a systematic, comprehensive review of each management unit through the lens of best-available-data. The goal would be to perform PHASE 2 in 2024-2026.

PHASE 1 Changes

Text changes are proposed to the CBEMP Part 1 to re-incorporate policies and management areas from individual plans into the primary document, thus realigning all three implementing jurisdictions under one master document. Text changes have also been proposed to enhance plan maintenance and coordination between jurisdictions. Other text changes are proposed to clarify management, fix scrivener's errors, and correct formatting errors.

Part 1, Appendix A, Maps, is proposed for amendment. The regulatory inventory maps, which include the Management Unit maps (M1-M1.8) and five (5) other mylar maps that were originally developed for the 1985 CBEMP adoption (M2, Shoreland Values, M3, Beaches and Dunes, M4, Dredged Material Disposal Sites, M5, Mitigation Sites, and M6, Wet Meadows) have been digitized. The digitized versions of these maps are proposed for adoption as part of this update. Appendix A is also being modified to include the background maps created as part of the Community Lands and Waterways Data Source. These digital maps, which are also incorporated into Part 2, Section 9, Coos Estuary and Shoreland Map Atlas, provide updated information on economic, social, and environmental conditions within the Estuary. No management unit boundaries or zone designations have been modified as part of these map updates.

Part 1, Appendix B, Matrices, is proposed for amendment. The three matrices (Goal #16 Linkages, Aquatic Uses and Activities Linkages, and Goal #17/18 Linkages) have been digitized. Content within the matrices has not been changed, however.

Part 1, Appendix C, Catalog of Historic Mylar Inventory Maps, is proposed for adoption. This appendix includes all mylar maps adopted as part of the 1985 Coos Bay Estuary Management Plan adoption. These maps remain in use as reference during development review.

The Data Source is proposed to replace portions of the written text in the CBEMP Part 2. Part 2 has also been edited for scrivener's errors and formatting.

Text changes are proposed to the City of Coos Bay and City of North Bend implementing ordinances to remove separate references to jurisdiction-only management units and/or policies. Rather, amendments are proposed to recommend adoption of the CBEMP by reference.

There are no new exceptions proposed at this time.

The CBEMP Part 1 and Part 2 have been provided in Track Change format for review. Text changes proposed to the CBEMP and jurisdiction implementing ordinances are shown as follows:

Overstrike: language to be removed.

Underline: language to be added.

Organization of this Memo

This memo discusses three categories of recommended revisions. They include:

- 1) Document Structure
- 2) Plan Usability
- 3) Land Use/Legal Framework

Recommendations are grouped by: proposed revisions to CBEMP Part 1 Plan Provisions; recommended changes to Part 2 Inventories and Factual Base; and necessary amendments to implementing ordinances in Coos County, Coos Bay, and North Bend.

Attachment A provides a summary of revised definitions.

Attachment B provides a detailed review of the recommended changes to Part 1 of the CBEMP.

CBEMP Part I

I. Adopt digitized version of the CBEMP Part I and enhance usability through hyperlinks and codification.

The CBEMP Part 1 has been digitized with a few hyperlinks to facilitate internal navigation. More hyperlinks may need to be added to increase ease of navigation. Alternatively, the document could be codified so that it is more accessible to the public.

Recommendation(s):

a) Adopt digitized version of CBEMP Part 1 with enhanced features to ease internal and external navigation.

2. Use clear headers to explain the purpose and contents of each document section.

The CBEMP document is organized into three (3) parts. Part 1 is then further divided into seven (7) sections. Due to the length of the document, it is important to provide clear headers, section briefs, and a list of each section's contents.

Part 1, Section 1.1 General Introduction provides a short outline of the document structure, including section descriptions. These section descriptions were used to develop Section purpose statements throughout the document.

Recommendation(s):

a) Insert purpose statements at the start of each section.

3. Use Figures and Tables to Explain Process and Policies.

Recommendation(s):

a) Insert flowchart for Part 1, Section 2.5 Relationship to Other Plans to visually communicate the connections between the CBEMP and other plans.

4. Integrate Map Atlas and Data Source into CBEMP.

Two documents, the Communities, Lands and Waterways Data Source (Data Source) and the Map Atlas, are being incorporated into the CBEMP. The Map Atlas is designed to bolster the factual basis of the CBEMP with up-to-date spatial data presented in a digital format. The Map Atlas also includes digitized versions of the original management unit maps and digitized versions of several mylar maps that are necessary for implementation of existing policies. The Data Source is a compilation of all available data describing the socioeconomic and environmental conditions in the Coos Bay area.

The following list (from the CBEMP Part 1, Appendix A) shows the list of maps that have been digitized without content changes (Digitized Mylar Inventory Maps) for this effort, and those that have been updated with new geospatial data (Background Data Maps).

Note: How the Data Source was integrated into Part 2, Inventories and Factual Base, is explained in Section 2, Table 3 of this document.

To integrate the Map Atlas and Data Source, any mentions of the prior data source or specific map(s) are being replaced with the corresponding data or map(s).

Recommendation(s):

- a) Insert reference to the CBEMP Management Units Map into the applicable estuary segments within Part 1, Section 5. Add full-size versions of the maps and estuary segment maps to Part 1, Appendix A.
- b) Modify table numbers and references to reflect the new Data Source throughout Part 1, Sections 6 and 7.

- c) Update map names and numbers to reflect new Map Atlas references.
- d) Remove Policy #3/Special Considerations Map in Part 1, Section 3.3 Policies. Update references to this policy and map to reflect the maps available in **Part 1**, **Appendix A**.
- e) Adopt digitized versions of the Goal #16 "Linkage" Matrix, Aquatic Uses and Activities "Linkage" Matrix, and Goal #17 and #18 "Linkage" Matrix as Part 1, Appendix B – Matrices.
- f) Retain a catalog of the historic mylar inventory maps (from original CBEMP adoption) as Part 1, Appendix C – Catalog of Historic Mylar Inventory Maps.

5. Correct inconsistencies between CBEMP and Ordinances and fix scrivener's errors.

Based on feedback from staff, we have recommended changes to rectify inconsistencies between document versions. These inconsistencies ranged from incorrect boundary descriptions to typographical errors that have been made in past updates to the CBEMP. We have also analyzed documents describing text amendments provided by City and County staff to ensure that text amendments that have occurred have been incorporated into the CBEMP.

Recommendation(s):

- a) Remove inconsistencies between implementing jurisdictions and ensure lawful text amendments made at a local level have been incorporated into the CBEMP.
- b) Fix scrivener's errors (formatting inconsistencies, typographical errors, spelling errors, etc.) within CBEMP.

6. Include all Management Units in the CBEMP.

The CBEMP has been updated to include all management units for Coos County, City of Coos Bay, and City of North Bend. Having all management units consolidated in the CBEMP will ensure consistency in implementation.

Some management units, which were enforced through the implementing ordinances of multiple jurisdictions, have diverged slightly in format or word choice over the years. We have noted or revised inconsistencies that were present between the different documents. Table 2 lists the impacted units. Attachment B describes the changes that are recommended to bring these management units into alignment.

To increase usability and streamline future amendment processes, the following recommendations are made:

Recommendation(s):

- a) Remove requirement that each city adopt those portions of the Plan that set forth the management units which lie within that city's boundary (Section 2.1 Plan Implementation).
- b) Reinsert all management units into Part 1, Section 5 of the CBEMP. Table 2 below lists the management units by jurisdiction to be reinserted into the CBEMP.
- c) Edit management units where necessary to bring into alignment between jurisdictions.

- d) Include Management Unit 9A-CS, which was not mapped on original mylars or digital zoning maps, in the digitized Map M1.
- e) Denote which jurisdiction holds review authority for each management unit at the beginning of the unit description. This will ensure interested parties consult the proper jurisdiction when inquiring about that management unit.

7. Capture Coos Bay-specific policies in CBEMP.

Two policies that existed only in the Coos Bay plan have been inserted into the CBEMP (Policy #45 Commercial Clam Harvest and Policy #71 East Catching Slough Road Widening Project). This allows Coos Bay to amend their implementing ordinances to use the CBEMP as their implementing plan, rather than requiring the City of Coos Bay to maintain their own version of the CBEMP.

Recommendation(s):

a) Reinsert Policy #45 Commercial Clam Harvest and Policy #71 East Catching Slough Road Widening Project into the CBEMP.

8. Include a comprehensive and consistent list of definitions.

The CBEMP contains a comprehensive list of terms and their corresponding definitions that are used within the CBEMP (Part 1, Section 3). Coos County and Coos Bay also include comprehensive definition sections within their ordinances, while North Bend's implementing ordinance refers to the CBEMP. In general, the implementing ordinances contain the same definitions that are used in the CBEMP. However, there are subtle differences in a few of the definitions.

We recommend all implementing ordinances rely upon the CBEMP for applicable definitions. However, there are some instances where we believe another definition would be more appropriate or a definition must be amended to align the documents. Attachment A includes a detailed review of the three sets of definitions and our recommendations. Preferred definitions are highlighted in grey in Attachment A.

Recommendation(s):

- a) Adopt revised CBEMP with modified definitions for use by all three jurisdictions.
- b) Revise specific definitions in Section 3.2 Definitions as needed to meet current federal and state legal and/or align with preferred definition from another jurisdiction. CBEMP definitions that are changing include: "coastal shoreland area," "development," "floodway," "restoration," "shoreline," and "solid waste disposal."

Update references to state and federal laws, regulations, agencies, and processes.

Changes have been included in the CBEMP to bring it up to date with current state and federal agency names, regulation references, permit processes, etc. Examples include: Division of State Lands => Department of State Lands, ORS 451 => ORS 198.610, etc. Text has also been added to the history of the CBEMP process (Section 1.3 Historical Perspective) to reflect recent efforts.

Recommendation(s):

- a) Correct references throughout document to federal, state, and local agencies and their permit processes or programs that have changed since the original date of adoption.
- b) Update references to Oregon Revised Statues and Oregon Administrative Rules as necessary.
- c) Include reference to current update in Section 1.3 Historical Perspectives.

10. Clarify joint plan maintenance and citizen involvement process.

Joint administration of the CBEMP has been a goal of the planning process from conception.

The Coos Bay Estuary and Shorelands Joint Management Agreement was adopted by the governing bodies of Coos County, North Bend, Coos Bay, and Eastside on November 8, 1982. This agreement was entered into by these four jurisdictions for "the purpose of facilitating orderly development within the Coos Bay Estuary and its Shorelands and for the purpose of maintaining the integrity of the coordinated Coos Bay Estuary Management Plan."

The agreement created a joint Coos Bay Estuary Advisory Commission (CBEAC), consisting of elected officials from each jurisdiction and the Port, to act as a planning advisory commission to local governments having jurisdiction within the Estuary. The commission was charged with conducting a formal review of the Plan every 2 years, reviewing plan amendments/revisions proposed by a local government unit, and providing a means for citizen input and comment on recommendations/revisions.

In 1994, the Board of Commissioners found that the CBEAC was no longer required for effective implementation of the Plan (Ordinance 94-09-017PL). Instead, the communities were to rely upon "other coordinating measures" that were available to maintain the document, including local implementing ordinances and regional planning efforts.

Unfortunately, the lack of formal joint coordination has led to the bifurcation of the CBEMP. Each jurisdiction has made amendments to management units within their boundaries without coordinating with each other to ensure that the CBEMP was also updated. This presents complications for applicants whose projects cross jurisdictional or management unit boundaries.

This group of changes is intended to clarify HOW the CBEMP will be maintained and updated as a multi-jurisdictional document moving forward, and WHO will take responsibility for updates.

Section 2.1 Plan Implementation has been amended to provide for co-management of the document with the County through a joint advisory committee who will look at and make recommendations related to proposed plan amendments and/or updates prior to their adoption by each jurisdiction.

This joint CBEMP advisory committee may consist of nine (9) or more members. Membership shall be as follows: one (1) member from the city of Coos Bay Planning Commission (appointed by Coos Bay City Council); one (1) member from the city of North Bend Planning Commission (appointed by North Bend City Council); one (1) member from the Coos County Planning Commission (appointed by the Coos County Board of Commissioners); one (1) member from the Port Authority (appointed by the Port Authority); two (2) members from the local Tribes (one (1) appointed by the Coquille Indian Tribal Council and one (1) appointed by the Confederated Tribes of the Coos, Lower Umpqua, and Siuslaw Indians Tribal Council); and at least three (3) interested citizens (one (1) each appointed by the Coos County Board of Commissioners, Coos Bay City Council, and North Bend City Council).

The proposed makeup of this committee is based upon comments received at the Joint Planning Commissions work session on January 4, 2023, at the Public Open House on January 7 and through comments received during the open comment period (February - May, 2023)...

Section 2.4 Citizen Involvement and Policy #39 Citizen Involvement have been amended to replace the current, defunct County-only citizen advisory committee with this joint advisory committee.

Recommendation(s):

- a) Modify existing language in Section 2.1 Plan Implementation, Section 2.4 Citizen Involvement, and Policy #39 Citizen Involvement, to reflect the multi-jurisdictional nature of the CBEMP's administration. Create a joint CBEMP advisory committee made up of representatives from all three jurisdictions, the port, both local tribes, and the community at-large.
- b) Modify existing language in Policy #36 Plan Update to delete references to "Periodic Review" and clarify process for updating of the jointly-adopted CBEMP, including identification of elements of a "comprehensive review and update" to occur when necessary, or at minimum every ten years.

CBEMP Part 2 – Inventories and Factual Base

The Communities, Lands, and Waterways Data Source (Data Source) is proposed to replace portions of the written text in the CBEMP Part 2. The Data Source is a compilation of all available data describing the socioeconomic and environmental conditions in the Coos Bay area. The Data Source provides users with indepth status and trends information about the Coos Bay Estuary's attributes, includes evaluations of those attributes, and highlights significant data gaps.

The Data Source is organized into 17 chapters divided into two parts. The Communities section (six chapters) characterizes socioeconomic status and trends in the project area, evaluates the area's social and economic attributes for comparison with other communities, and provides the Data Source with critical historical perspectives. The Lands & Waterways section (eleven chapters) characterizes and evaluates the status and trends of the project area's environmental attributes and describes the likely effects of climate change on those attributes.

The Data Source was developed by the Partnership for Coastal Watersheds (PCW), a group of civic-minded local community members representing county and city planners, natural resource managers, and development and conservation interests.

A comparison of content from the CBEMP Part 2 and the Data Source is displayed in Table 3 below. The CBEMP table of contents has four tiers; only the first two tiers are displayed in the table. The table indicates which sections of the CBEMP Part 2 are replaced by sections of the Data Source and which sections are retained.

Unless otherwise noted, the changes referenced in the "Suggested Action" column in Table 3 have been included in the revised CBEMP Part 2.

Recommendation(s):

a) Revise Part 2 of the CBEMP to incorporate the 2018 Communities, Lands, and Waterways Data Source (Data Source).

Implementing Ordinance(s)

Below are the changes and recommendations related to the implementing documents, including the Coos County Comprehensive Plan (Volume II), Coos County Code, City of Coos Bay Comprehensive Plan (Volume 3), City of Coos Bay Development Code, and City of North Bend Comprehensive Plan. Information is provided below for each City's version of the comprehensive plan and/or implementing ordinance.

1. Digitize and Codify.

For all ordinances, it is recommended to publish searchable PDFs on each jurisdiction's website. Eventually, it is recommended that the CBEMP be codified. Codification will provide all three governments and their citizens with current, enforceable regulations in a format that makes the regulations easy to use and reference. When the joint agencies decide to modify the CBEMP in the future, the codified document can be updated to reflect those changes. Initial codification may cost in the realm of \$5000, with additional fees due when changes are made.

Recommendation(s):

a) Improve usability of the CBEMP through the publication of a searchable version of the CBEMP for use by all three jurisdictions.

2. Modify implementing ordinances to adopt 2023 CBEMP.

To adopt the updated CBEMP Parts 1 & 2, including the digitized Map Atlas and the Communities, Lands and Waterways Data Source, modifications will be necessary to the implementing ordinances of Coos County, Coos Bay, and North Bend. Existing sections of local code, which include all or parts of the CBEMP, including management units, will need to be deleted and replaced with references to the revised CBEMP. The following section reviews proposed changes to each implementing ordinance.

Recommendation(s):

a) Coos County Comprehensive Plan (Volume 2)

The CBEMP is adopted as Volume 2 of the Coos County Comprehensive Plan. Volume 2, Part 1 and Part 2 of this section of the Comprehensive Plan will have to be rescinded and the new version of Parts 1 and 2 adopted to update the CBEMP.

Recommendation(s):

1) Amend Volume 2 of the Coos County Comprehensive Plan to replace the current versions of Parts 1 and 2 of the CBEMP with updated versions.

b) Coos County Enabling Ordinance (Coos County Zoning and Land Development Code, Chapter 3)

The enabling legislation in Coos County is the Coos County Zoning and Land Development Code.

Changes proposed to Chapter 3 of the Coos County Zoning and Land Development Code to bring it into alignment with the revised CBEMP include:

- Management Unit Uses and Activities are removed.
- References to "management segments" are changed to "management units." References to the "Special Considerations Map" are changed to the "Generalized Zoning Map".
- Users are directed to the CBEMP for specific zoning provisions that correspond to the map designations.

Recommendation(s):

1) Adopt a revised Chapter 3 that references the CBEMP as its primary document and removes specific management unit descriptions.

c) City of Coos Bay Comprehensive Plan (Volume 3)

The CBEMP is implemented through Volume 3 of the City of Coos Bay Comprehensive Plan. This document incorporated that portion of the CBEMP that was applicable within Coos Bay. It had been modified over the years so that it had several discrepancies with the CBEMP.

As the CBEMP has been realigned with the City of Coos Bay's Volume 3, it is our recommendation that Volume 3 be rescinded in its entirety and replaced with a reference to the CBEMP as the master document.

Recommendation(s):

- Rescind Volume 3 and substitute it with a reference to the CBEMP as the guiding management document.
- 2) Replace references to the CBEMP Shorelands Map with references to the appropriate maps in the Map Atlas.

d) City of Coos Bay Implementing Ordinance (Development Code Chapter 17.352)

The City of Coos Bay's Development Code (Chapter 17) includes a Chapter on Estuarine and Coastal Shoreland Uses and Activities (Chapter 17.352). This code incorporates the Coos Bay Estuary Management Plan and establishes the process for how applications are reviewed and approved for uses and activities within the estuary. Necessary changes include:

- Section 17.352.040 Tentative Decisions must be modified to reflect the Map Atlas.
- References to Volume 3 must be replaced with references to the CBEMP.

Staff are also proposing to amend Section 17.352 to better reflect the current format of the Coos Bay Development Code and clarify administrative procedures.

Recommendation(s):

1) Adopt ordinance replacing existing Section 17.352 of the Coos Bay Development Code with revised section, incorporating 2023 CBEMP Parts 1 & 2 and clarifying administrative procedures.

e) City of North Bend Comprehensive Plan

The Coastal Element of the North Bend Comprehensive Plan is intended to be maintained so that it is consistent with the CBEMP. (Article 12.5.100 Policies (2))

The North Bend Comp Plan includes the following language:

Article 12.6.100 Implementation Requirements -- The Coos Bay Estuary Management Plan has been designed to provide coordinated management within the Estuary. The Cities of North Bend and Coos Bay and Coos County have adopted the CBEMP as part of their respective comprehensive plans. The City of North Bend will follow the implementation strategies, policies and allowable uses outlines in the Coos Bay Estuary Management Plan.

This language does not need to be amended to adopt the new CBEMP. However, the CBEMP Shoreland Estuary Management Map is adopted by reference into the North Bend Comprehensive Plan. This map needs to be rescinded and replaced with a reference to the revised CBEMP Parts 1 and 2 (including its updated maps).

Recommendation(s):

1) Update the North Bend Comprehensive Plan to adopt the revised CBEMP by reference (removing reference to old Shoreland Estuary Management map).

f) North Bend Implementing Ordinance (Title 18, Zoning, Chapter 18.88)

North Bend City Code Chapter 18.88: Coos Bay Estuary Management Plan is located within Title 18, Zoning of North Bend City Code (NBCC). Ordinance 1952 § 1(4), 2006, adopted the portions of the CBEMP that are applicable to land located in, or owned by, the City of North Bend. This code references the CBEMP, but does not need to be amended, provided that the updated version of the CBEMP be adopted as part of the North Bend Comprehensive Plan (above).

Recommendation(s):

1) No changes.

Section 1.5 Citizen Involvement Program: A reference to the appointment of a joint CBEMP Advisory Committee has been inserted to facilitate coordination of ongoing updating of the multi-jurisdictional CBEMP.

SECTION 2 POLICIES FOR FUTURE PROCESSES:

Below are listed recommended changes to Policies for Future Processes.

Section 2.1 Plan Implementation: Changes are proposed to this section to clarify how the plan will be implemented in the future. The proposal inserts a joint advisory committee with representatives from all three jurisdictions, the port, the tribes, and the community at-large, who are responsible for reviewing and making recommendations on any proposed change to the CBEMP prior to initiation of any amendment by the County and Cities. Proposed changes also include the deletion of the requirement for each jurisdiction to adopt applicable management units in their local code.

Section 2.4 Citizen Involvement: Changes are proposed to this policy to recognize joint management of the CBEMP by Coos County and the cities of North Bend and Coos Bay. A Joint CBEMP Advisory Committee is recommended to replace the defunct Coos County Citizens Advisory Committee as the committee responsible for on-going maintenance of the CBEMP.

Section 2.5 Relationship to Other Plans: Figure 1: Coos Bay Estuary Management Plan's Relationship to Other Plans and Jurisdictions has been added for clarification.

SECTION 3 MANAGEMENT FRAMEWORK:

Below are listed recommended changes to the Management Framework, including definitions, and Baywide Policies. If not mentioned below, any difference noted in the Coos Bay Plan was not carried forward to the CBEMP revisions.

3.2 Definitions: Changes were made to the following CBEMP definitions (see Attachment A) to reflect more comprehensive or regulatorily consistent definitions used in other implementing ordinances (Coos Code, for example):

3.3 Bay-Wide Policies:

Policy #2: Management Unit: Natural -- No Special Assessment Required (A)(5). Added the word "resources," which was missing, to align current Goal 1 language.

Policy #2: Management Unit: Natural -- No Special Assessment Required (A)(9): The phrase "and bridge crossing support structures" was added to align with current Goal 16 language.

Policy #2: Management Unit: Natural -- No Special Assessment Required (A)(10). Added the category, "Rip-rap for protection of uses existing as of October 7, 1977, unique natural resources, historical and archeological values; and public facilities" to align with current Goal 16 language and match the Coos Bay Plan.

Policy #2: Management Unit: Conservation – No Special Assessment Required (A)(1). Deleted

"permitted outright" for clarification (as all uses allowed with or without special assessment in the Natural Management Unit are allowed in Conservation units).

Policy #2: Management Unit: Conservation Special Assessment Required (B)(4). Added language to align with current Goal 16 language and match the Coos Bay Plan.

Policy #2: Management Unit: Development -- No Special Assessment Required (A)(1). Language updated to match Coos Bay Plan. Note: The updates reference a "shallowdraft estuary" as defined in the CBEMP.

Policy #2: Management Unit: Development No Special Assessment Required (A)(8). Language updated to match Coos Bay Plan.

Policy #2: Management Unit Development Special Assessment Required (B)(5). This category was added to the CBEMP; it is referenced in the Coos Bay Plan.

Policy #3: Use of "Coos Bay Estuary Special Considerations Map" as the Basis for Special Policies Implementation". This policy reference was removed and is now Reserved. The inventory maps are in Appendix A of the revised CBEMP.

Policy #4: Resource Capability Consistency and Impact Assessment. Additional text was added to match the Coos Bay Plan following subcategory "d".

Policy #5: Estuarine Fill and Removal. "Compliance with local floodplain development permit requirements" was added to reference overlap with existing local floodplain regulations.

Policy #6: Fill in Conservation and Natural Estuarine Management Units. Additional text was added to this policy to refer to existing floodplain development regulations that are triggered by the location of dredged materials in Special Flood Hazard Areas.

Policy #16a: Minimum Protected Acreage Required for County Estuarine Shorelands. Format and content changes were made to divide the portions applicable to Coos County and the City of Coos Bay. The Coos County acreage totals were last updated August 8, 2013. Acreages for Coos Bay were last updated July 6, 2010.

Policy #20b: Priority for In-Bay Subtidal Disposal Sites. Coos Bay references in-bay site "D" while the CBEMP references site "8.4"; these are the same site and the text has been updated to reflect this. The CBEMP references site F which is in the open ocean; the Coos Bay Plan references in-bay site G which is within the navigation channel. The text has been revised to reference in-bay site G.

Policy #22b: Limiting Dredge and Fill as Estuarine Restoration. A reference to local floodplain ordinances was included in this policy, to reflect overlap of existing regulations.

Policy #23: Riparian Vegetation and Streambank Protection. No changes. Note: Streambank protection is listed as Policy #25 in the Coos Bay Plan.

Policy #25: Waste/Storm Water Discharge. No changes. Note: The Coos Bay Plan does not include this policy.

Policy #27a: Floodplain Protection within Coastal Shorelands. Number was changed to 27a; no other changes.

Policy #27b: Natural Hazard Protection within Coastal Shorelands. This policy was added by the County to respond to natural hazard concerns.
