Final Ballot Title The following is the final ballot title of the measure to be submitted to the district's voters. The ballot title notice has been published and the ballot title challenge process has been completed.

A five-year levy to maintain & improve ambulance operations.

Question 20 words which plainly phrases the chief purpose of the measure.

Shall the Health District maintain ambulance operations by levying \$0.30 per \$1,000 assessed valuation for five-years beginning in 2024/2025? This measure may cause property taxes to increase more than three percent.

Summary 175 words which concisely and impartially summarizes the measure and its major effect.

Passage of this measure will allow the Myrtle Point Health District to maintain and improve ambulance staffing and equipment for a five year period.

The funds generated from this tax will be used to pay for increased operating costs such as fuel, personnel, & equipment. It will be used to maintain Paramedic level response to life threatening emergencies, replace/improve aging equipment, maintain training, & help the District keep pace with the large increase in calls for emergency services.

After five years, this tax rate will expire unless re-approved by voters within the Health District. This measure will generate revenue for five years beginning in 2024. For a typical \$230,000 home in the District, the annual tax payment would be roughly \$69, or \$5.75 per month.

The ESTIMATED taxes raised by this levy are 2024/25-\$145,996.00, 2025/26-\$150,375.88, 2026/27-\$154,887.15, 2027/28-\$159,533.76, 2028/29-\$164,319.74 for a total of \$775,112.53 over five (5) years. The estimated tax cost for this measure is an ESTIMATE ONLY based on the information available from the county assessor at the time of the estimate.
