The undersigned agrees to execute and deliver the contract, initial payment, required certificates of insurance, and performance bond, within thirty (30) days of the date of the written notification of high bid; and that any cash bid deposit may be applied to the first required sale payment.

The undersigned understands that the bid is irrevocable and further agrees that if he/she fails to qualify under the terms of the contract within the thirty-day period, the bid deposit shall become the property of Coos County as liquidated damages.

NOTE: The completed "Certification of Eligibility to Bid Form" must be enclosed, and the following "Certification of Independent Price Determination" must be signed.

CERTIFICATION OF INDEPENDENT PRICE DETERMINATION: Subject to the penalties prescribed in 18 U.S.C. 1001, and ORS 646.705 through 646.836 bidder certifies and represents, by signing this bid form, that the following representations are accurate and complete:

- A. By submission of this bid each Bidder also certifies, and in the case of a joint bid each party thereto certifies as to its own organization, that in connection with this sale:
1) The prices in this bid have been arrived at independently, without consultation, communication, or agreement, as to any matter relating to such prices with any other bidder or with any potential competitor;
2) The prices which have been quoted in this bid have not been knowingly disclosed by the Bidder and will not knowingly be disclosed by the Bidder prior to opening of bid, directly or indirectly to any other bidder or to any potential competitor; and
3) No attempt has been made or will be made by the Bidder to induce any other person or firm to submit or not to submit a bid.

B. Each person signing this bid or proposal certifies that:

- 1) The Signer is the person in the Bidder's organization responsible within that organization for the decision as to the prices bid herein and that the Signee has not participated, and will not participate, in any action contrary to A (1) through A (3) above; or
- 2) The Signer is not the person in the bidder's organization responsible within that organization for the decision as to prices bid herein but that the Signer has been authorized in writing to act as agent for the persons responsible for such decision in certifying that such persons have not participated, and will not participate, in any action contrary to A (1) through A (3) above, and as their agent does hereby so certify; and that the Signer has not participated, and will not participate, in any action contrary to A (1) through A (3) above.

C. A bid will not be considered for award where any portion of A or B above has been deleted or modified. Where these provisions have been deleted or modified the bid will not be considered for award unless bidder furnishes with the bid a sworn statement which sets forth in detail the circumstances of the disclosure and the County Forester, or designee, determines that such disclosure was not made for the purpose of restricting competition.

- (c) Are not prohibited by the Forest Conservation and Relief Act of 1990; ORS 526.801 to 526.831 and 526.992 as excepted by Resolution 92-01-200L or the County's export provision (Standard Provisions Section 42) from bidding for County timber directly from the Coos County Commissioners.
- (d) Understand that falsely entering into this certification is a violation of ORS 526.801 to 526.831 and 526.992, the Forest Conservation and Shortage Relief Act of 1990, the County's export provision and other state and federal provisions, and subjects the undersigned and the company to any and all penalties contained therein.
