SUMMARY:

Alternative Youth Activities has procured and renovated properties, signed block leases, and subleased to formerly unhoused people. We are requesting reimbursement for these eligible expenses from HB5019 rapid rehousing funds. We expect to rehouse 15 people in this project.

ACTION REQUESTED:

"Motion to approve the initial and monthly draws from HB5019 funding for rapid rehousing project as proposed by Alternative Youth Activities"

BACKGROUND:

The South Coast has a vacancy rate of 1%, meaning that there are few opportunities to house the homeless since there is little housing available. As part of this program, AYA has four points of focus to be able to create additional housing opportunities for those served.

- Secure additional housing
- Create housing opportunities utilizing a block lease agreement with property owners.
- Case management from homeless-to-housed using HUD definitions and calculation tables.
- Secure stepped-housing opportunities



INTRODUCTION

Alternative Youth Activities (AYA) has been a contributing service provider in the South Coast for over 40 years. Originally focused on providing education to youth for whom traditional education models did not succeed, AYA quickly identified additional needs for the underserved and vulnerable populations within the community. In recent years, AYA has developed support programs including food and nutrition, case management, counseling, connection to mental health providers, and housing. AYA is an essential ingredient in the continuum of services becoming known as Coos County Nurturing Community.

AYA champions collaborate effort in everything it does. In order to better address the homeless population on the South Coast, it is imperative that service providers **communicate**, **collaborate**, **and coordinate** (the Three Big Cs). Programs designed for the target population should also include input from those served, and should be consistent across providers— all delivered with attention to the needs of the client. By involving program participants in helping in determining what success looks like for them, and planning with that goal in mind.



OVERVIEW

AYA proposes an increased collaboration with providers related to the COOS COUNTY COORDINATED OFFICE OF HOMELESSNESS STRATEGIC PLAN, adopted on April 18, 2023, for the Southern Coast Oregon area.

Our strategy is four-pronged:

- Further embrace a Continuum of Care (CoC) for the region to develop and encourage systemic partnerships between/among providers.
- Create a system in which the homeless can progress from homelessness to housed in steps that prepare them for independent living rather than in a singular move.
- Case management from homeless-to-housed using HUD definitions and calculation tables.
- Create housing opportunities utilizing a block lease agreement with property owners.



CONTINUUM OF CARE

A "Continuum of Care" involves an integrated system of care that guides and tracks participants over time through a comprehensive array of social services spanning all levels of intensity of care.

AYA champions collaborate effort in everything it does. In order to better address the homeless population on the South Coast, it is imperative that service providers **Communicate, Collaborate, and Coordinate** (the Three Big Cs). Programs designed for the target population should also include input from those served, and should be consistent across providers— all delivered with attention to the needs of the client. By involving program participants in helping in determining what success looks like for them, and planning with that goal in mind.



SUPPORTIVE HOUSING INITIATIVE

Any housing initiative that doesn't take housing inventory into account is doomed to failure.

The South Coast has a vacancy rate of 1%, meaning that there are few opportunities to house the homeless since there is little housing available. As part of this program, AYA has four points of focus to be able to create additional housing opportunities for those served.

- Secure additional housing
- Secure block leases
- Collaborate with land lords of unused property
- Secure stepped-housing opportunities



IDENTIFYING TARGET POPULATIONS

Alternative Youth Activities advocates for coordinated care partners using consistent criteria for identifying and approving services. To this end, criteria should be established and widely used by other entities.

- HUD Definition of Homeless including McKinney-Vento
- HUD Calculations of Income when determining Low-to-Moderate Income (LMI) Households
- Critically Underserved and Restrcted Service (SUD, SPMI, Sex Offenders, Arsonists)

Once the units are fully occupied, the waitlist prioritization will include eligible Coquille Tribal members, members of other tribes, and then the public.

 - Reunite families and reduce the number of children entering the child welfare system. We seek to be an alternative to foster care, where appropriate.
 - Judy Hui-Pasquini from OHCS. She wanted to discuss a future program through their agency which would primarily focus on rapid rehousing for children and their families experiencing homelessness.
