SUMMARY:

Point in Time Count

- The team has spent the last month since our last meeting continuing to support efforts surrounding the Point in Time Count. Doing brush counts in outlying areas, partnering with local churches to count as many individuals as possible, and providing technical support and guidance to those entering information into the Counting Us App. The raw numbers show a drastic decrease in participants in the count. It has been determined that there has been a problem with how our information was entered. Discussions with the ROCC and the developer of the app Semtech, have given us more insight into where the missing data has gone. A comparison between what the app command center and raw data indicates that data from our county has been disqualified due to how some of the questions were answered. We have requested a review of the raw data to see where the disconnect happened to see if there is a way to remedy the issue. This was not just a Coos County issue this affected other counties within the ROCC.
- Discussions with partners during our monthly stakeholder meetings have given us some good data on how we could improve our efforts next year.
- ORCCA will hold a post-pit count meeting to determine how this project will continue improving.
