SUMMARY:

- Salvation Army/ Deveraux Center Warming Shelter Collaboration
 - We able to facilitate the signing of the contract between Salvation Army and The 0 Deveraux Center Warming shelter and the shelter should be operational and ready for services when/if the need arises
- Salvation Army Hope Village Project
 - There have been various meetings between the agencies involved in this project to 0 solidify funding and come to an agreement on specifics. There was a meeting this Friday December 15, 2023 contracts between the Coquille Indian Tribe and the Salvation Army will be signed and ready to go by the end of January.
- Community and Agency Outreach
 - Our team has continued to hold our 3 Stakeholder Advisory meetings the 1st, 2nd, and 3rd 0 Thursdays each month. As we are able to make more connections, we're seeing more participation and collaboration between agencies.
 - We have been able to establish a new connection with the North Bend Ministerial group to discuss the Point in Time Count as well as other projects that our office is involved in
 - We have spoken about our program and what we are working on at the last few Chamber 0 lunches and we are on the schedule for a full presentation in January.
 - We continue to work on more updates to the county website as well as our Facebook page to make our work and collaboration opportunities more accessible.
- Point In Time Count 2024
 - This week we began recruiting the McKinney Vento liaisons with the school districts in an 0 effort to capture a broader picture of our homeless situation in relation to children and families.

- Through our community stakeholder meetings, we were able to secure the use of the Salvation Army van for the PIT count as well as the mobile case management unit from ODHS.
- A medical service provider has been secured through Coos Health and Wellness to triage wound care and administer vaccines.
- PIT Count Volunteer sign up went live Friday December 15, 2023 people can sign up by clicking <u>ORCCA Volunteer Sign-up</u>
- We have almost finished developing the training for the "Counting Us" app. This material will be offered online as well as in person for PIT count volunteers.
- We have also been working with Scott Cooper from AYA as well as Tara Johnson from The Deveraux Center on how to conduct interviews in the most Trauma Informed way possible. We will have a video to demonstrate effective techniques available for volunteers during orientation training as well.
- Office Needs
 - We have found that throughout our various meetings and connections that it's become necessary for us to have business cards.
 - Cost is approximately \$55.00
