Re: Coos County Planning Department File No. AP-19-003

This is an official Coos County Planning Commission Notice of Decision. On June 6, 2019 the Coos County Planning Commission voted to deny the appeal, File No. AP-19-003, and uphold the Planning Director's approval of an extension (EXT-19-001) for an Administrative Conditional Use (ACU-14-032). ACU-14-032 granted land use authorization to site a single-family dwelling (forest template dwelling) within the Forest Mixed Use (FMU) zoning district. The subject property is described as Township 23S Range 13W Section 35BB Tax Lot 100. The approval has not and can not be modified to allow any other land use authorization. Modifications to a prior land use authorization can not be made through an extension.

The Planning Commission's decision is final unless appealed in writing to the Board of Commissioners within 15 days from the Date of Mailing on June 26, 2019. This means appeals must be received in the Planning Department by 5:00 p.m. on the date of the identified appeal deadline in order to be considered. The appeal shall be filed pursuant to Coos County Zoning and Land Development Ordinance (CCZLDO) Article 5.8, and shall be accompanied by a written statement of the grounds for the appeal and the required filing fee. Appeals before the Board of Commissioners may be limited to the record.
