We are Coos County landowners that were previously on several routes of the Pacific Connector Gas Pipeline (PCGP) and are registered Intervenors on this Federal Energy Regulatory Commission (FERC) project.

After examining the County Planning Departments writeup on this permit extension, it is evident that the County is not using the final route that was approved by FERC, contingent on the applicant, Pembina, acquiring a number of other permits. Instead, Coos County is using an obsolete 2009 routing of the project. If approved, what this permit would do is place a disclosure requirement on these landowners that ultimately could affect the usability and sale-ability of their properties. We request that the County amend this permit and remove landowners that are not on the official "FERC approved" route and give back full use to these individuals.

Based on the information we have, it appears that the following landowners should be removed from this permit because they are not on the "FERC approved" route.

Even though some of these landowners may have sold easements for the Jordan Cove Energy Project, the fact remains that they are not on the "FERC approved" route and their names should be stricken.

If the County has information from Pembina or has had discussions with FERC that the 2009 route, as poorly illustrated on the County's information sheet, we, as intervenors, demand to know the nature of these discussions or communications.

We, in fact, flat out would like an answer to this question: Has the county, its commissioners or agents, had any discussions with Pembina or FERC about using the unapproved segments of the 2009 PCGP route? Please let us know.

There are a number of other issues with the routing that the County is currently considering. They are:

- 1. Significant cultural resources that would be destroyed by the installation of a pipeline in Haynes Inlet and at Graveyard Point.
- 2. We question whether there was appropriate notification of all the adjacent landowners for this proposal. A case in point, we own property adjacent to one of the State land parcels that is crossed by this route in Haynes Inlet as shown in the map included with the file. Why were we not notified? Are there other landowners that were not notified, including adjacent and those landowners on this outdated, 2009 alignment.
- 3. Exhibit "C" in the staff report, is riddled with mistakes as to the correct parcel acreage listed.
