On December 28, 2021, the Board of Commissioners Adopted Final Decision and Order No. 21-10-009PL. The applicants Jeremiah and Bridget Kasper applied to amendment to the Coos County Comprehensive Plan Map and the Coos County Official Zoning Map by Rezoning the subject property from the current Plan Map Designation Agricultural to Forest and included in the Mixed Use Overlay and amend the Official Zone Map Designation from Exclusive Farm Use to Forest/Mixed Use subject to Coos County Zoning and Land Development (CCZLDO). The Subject Property in which the Plan Map Amendment is proposed is identified as Township 29S, Range 14W, Sections 08, Tax Lots 302 and 301. These properties are located south of the City of Bandon and accessed off of Circle City Lane, via Barnekoff Lane onto Rosa County Road.
